ⁱ **Tech Hub** – *The bidder failed to meet the Bid Securing Declaration requirement, as the Bid Securing Declaration was not completed or signed.*

ⁱⁱ **Spark International LLC** – This bidder did not meet the verification requirement because *authorisation to commit the bidder to sign the bid was not seen*. In addition, the bidder failed to meet the Bid Securing Declaration requirement *as it was not included in the bid*. Further, the bidder failed to meet the completeness of the bid requirement as *the spare parts were not provided*.

ⁱⁱⁱ **Beachcomber Limited** – This bidder did not meet the verification requirement because *authorisation to commit the bidder to sign the bid was not seen*. In addition, the bidder also failed to meet the bid securing declaration requirement as *the period of time is stated as 14 months instead of 2 years, which is less than the time requested*. Further, the bidder failed to meet the completeness of the bid requirement as *spare parts requested were not provided* and lastly, the bidder failed to meet the substantial responsiveness requirement as *the technical specifications offered manual transmissions instead of automatic transmissions requested*.

^{iv} **Angloco Limited** – *The bidder failed to meet the bid securing declaration requirement as the period of time is stated as 12 months instead of 2 years, which is less than the time requested.*

^v **Amalgamated Security Services Limited** – This bidder did not meet the verification requirement because *authorisation to commit the bidder to sign the bid was not seen*. The bidder also failed to meet the bid securing declaration requirement as *Period of time is stated as 12 months instead of 2 years, which is less*.

^{vi} **Abronn FZE** – Failed to meet one key requirement of the technical specifications
Engine: (Diesel, **must be able to use High Sulphur Diesel**). **The bidder confirmed that the vehicle is not compatible to use with high sulphur diesel**
