#### **Project Outcome/Description:**

The outcome of the Project is improved access to Early Childhood Development (ECD) and primary education for poor children ages 3–12 in under-served populations; and enhanced equity, quality and governance of the education sector. The project will support the implementation of elements of the Government's Operational Plan for Education (OPE) in collaboration with WB.

The Project constitutes the second phase of the Education for All Project and consists of the following four components:

#### (a) Component 1: Improving Access to Quality Primary Education:

- (i) Improving the quality of the Tuition Waiver Programme;
- (ii) Improving basic educational services in selected Rural Communities; and
- (iii) Strengthening the Recipients' School Health and Nutrition Programme.

#### (b) Component 2: Support to Teaching and Learning:

- (i) Expanding the number of certified teachers, including preschool teachers;
- (ii) Improving ECD and primary school performance.

#### (c) Component 3: Institutional Strengthening and Governance:

- (i) Building the institutional capacity of MENFP to improve service delivery and overall educational governance; and
- (ii) Strengthening of public-private partnerships.

# (d) Component 4: Project Management, Monitoring and Evaluation: Strengthening MENFP's monitoring and evaluation capacity.
